



# Rules of « Last Checkpoint » contest

# **Article 1 : Organization**

Reunion's Roland Garros Airport with capital of 148,000 euros, designated under the name "The organization", whose head office is located at 74 avenue Roland Garros 97438 Sainte-Marie, registered under RCS Saint-Denis de La Réunion number B 528 194 434, organizes from Friday 18 to Sunday 27 October 2024, "Last Checkpoint" contest. This game takes place on the Departure way at Reunion's Roland Garros Airport.

# **Article 2: Participants**

This game without obligation to purchase is open to adults and minors.

Minors may participate in this game, provided they have previously obtained authorization from their parents or the person responsible. Their participation implies that they have obtained such authorization.

This game is exclusively for passengers from Reunion's Roland Garros Airport.

Persons not meeting the above conditions are excluded from the game, as well as members of The organization's staff and anyone who has directly or indirectly contributed to the creation, production or management of the game, and their spouses, Members of their family and/or household.

Only one entry per household (same name, same address) is allowed. The organization reserves the right to verify compliance with these conditions, and to remove abusive participations.

The organization reserves the right to ask any participant for proof of the conditions mentioned above. Anyone who is unable to provide the required evidence may be excluded from the game, and will not benefit from his win.

Participation in the game implies acceptance of the rules, without reservation.

#### **Article 3: Modalities of participation**

From Friday 18 to Sunday 27 October 2024 at 23h59, passengers will be able to participate without obligation to purchase to the game of Reunion's Roland Garros Airport.

In order to particiapte, passengers will have to follow these rules:

- Access the game by scanning the QR code accessible on the "TOTEM" located in the airport in the reserved area of the Departure way.
- Complete the chatbot form with his or her contact details (name, surname, email address).
- Participate to the "Last Checkpoint" digital game on mobile phone.
- If it is won, the voucher is sent directly to the participant by e-mail. It can then be used in the shops of the boarding lounge only.

Participation is unlimited for the duration of the transaction. Participation in the digital "winning instant" game is accessible through QR codes located in the airport's boarding lounge. Any participation made through other means will render the participation invalid. Any participant suspected of multi-participation by trade may be excluded from the competition by the organization, without justification being required. Any incomplete or erroneous identification or entry will be considered void. The same penalty will be applied in case of multi-participation by trade.

## **Article 4: Winnings**

The number of vouchers to be won and their value:

- 100 vouchers of 10€
- 100 vouchers of 5€

Total value of vouchers: 1 500 €

The value of vouchers is determined when writing the present document and cannot be disputed later.

Vouchers are for single use, non-exchangeable, non-refundable, non-cumulative and to be used on the day of receipt. After this date, winners will no longer be eligible.

The vouchers won can be used in the shops of the airport's boarding lounge. (Valid on all products without tobacco, scratch cards and books).



The endowment is nominative and may not be contested in any way, nor to the surrender of their value in cash (total or partial), nor be exchanged or replaced by another lot of any value for any reason whatsoever.

#### Article 5: Selection of winners

The contest being a winning instant, the participant will be immediately informed if he has won. The voucher will be automatically sent to the winner by email.

Vouchers will be redeemed by a person upon presentation of the voucher at the cash desk. No copies or reproductions will be accepted.

### Article 6: Use of participants' personal data

The data collected about you is processed by Reunion's Roland Garros Airport (SA ARRG) to manage participation in the contest called the «Last Checkpoint».

The recipient of the data is ARRG SA and its subcontractors: «les sales gosses» agency and «Fastory».

Subject to your explicit consent, the information collected may be used by ARRG SA in order to send you commercial offers from the airport and its partners.

You have the right to access, rectify, erase, limit, transfer, object to processing of your data and the right to define guidelines regarding the fate of your data after your death. # Article 8: Industrial and intellectual property

Any unauthorized reproduction, in whole or in part, of these elements will be subject to sanctions.

# **Article 9: Liability**

The organization cannot be held liable in case of force majeure or event beyond its control.

The organization cannot be held responsible in case of an event that deprives participants of the opportunity to participate in the game, or to recover their prizes.

The organization and its partners will not be held responsible for any incidents that may occur during the use of the prizes by the beneficiaries or their guests from the moment the winners have taken possession of them.

Likewise, the organization and its partners will not be liable for loss or theft of prizes once they have been collected by the winners. Any additional costs related to the recovery of prizes are borne by the winners, without being entitled to compensation.

#### **Article 10: Litigation & Claim**

These Rules is governed by the French law.

The organization reserves the right to decide without appeal any problem that may arise regarding the interpretation or application of the rules, knowing that no dispute can be taken into account in particular on the terms of the contest, on the results, on the lots or their receipt, one month after the end of the contest.

Any complaint must be submitted to the organization within one month of the end date of the game. After this time, no claim will be accepted. Participation in the contest implies acceptance of these rules and their conditions.

#### Article 11: Convention of Evidence
